Payment Terms Monthly installments for Harmony, Health and Healing, LLC “Massage Membership” shall be \$___ for a term of 12 months to be debited each month and will be automatically debited from the member’s registered credit/debit card. The payment is debited monthly on the first of the month. The monthly charges will continue automatically each month for 12 months, or until the termination of the membership. Membership Freeze This membership may be temporarily frozen for up to 90 days. The contract freeze will stop automatic payments scheduled during the period of the freeze from being charged and will also suspend all membership benefits during the same period. Automatic payments will continue immediately following the period of the contract freeze, as will full membership benefits. All requests for membership freeze must be submitted to Harmony, Health and Healing, LLC management at least 10 days in advance of the requested freeze start date. Member’s that choose to take advantage of the membership freeze should be aware that use of this feature will extend the contract the number of days/weeks/months equal to the length of the contract freeze.

Termination To cancel this membership, a 30 day advance is required but can be done at any time. All requests for membership cancellation must be submitted to Harmony, Health and Healing, LLC management. Once we have received and completed your request for cancellation the next scheduled monthly charge and all those that were to follow will be cancelled. Membership will be valid until, but not on, the date of the first cancelled payment; after that date, all member benefits will be cancelled.

Details and Fine Print

- If massages are not used for whatever reason during any month, that massage will carry over for you to use the following month or any month thereafter. The massages that you accrue do not have an expiration date, but we do encourage you to stick to your monthly regimen since for your ideal health and wellness program.
- You are being given a discounted service by becoming a member of the “Massage Membership” with Harmony, Health and Healing, LLC.
- You are allowed to gift one of your membership massages every 3 months as you wish to another person.
- We have a 24-hour cancellation policy. If you miss an appointment without this notice, you will be charged a \$25 cancellation fee or your massage for that month will be forfeited.
- While tips are not required or expected, they are always much appreciated. It is customary to leave a tip based on the regular price of the service. Regular price per session is \$70 for 60 mins/\$100 for 90 mins and \$120 for 2 hours.
- Some clients appreciate the tip being automatically deducted with the monthly payment. We are happy to provide that for you and ask that you fill in the desired amount here if you would like this service. If not desired, please leave blank \$ _____
- Enjoy extra time at a discounted rate when you are a member! We ask that you request this to Harmony, Health and Healing, LLC at least 24 hours in advance so they can do their best to accommodate. We cannot guarantee extra time can be given and can only suggest that giving management more time to accommodate for this will increase your chances of acquiring extra time when desired.
- Extra time offered would be: 15 mins/\$10 30 mins/\$25. If different time frames are desired than stated here, please speak with management and we will do our best to accommodate you.
